Voice of the President: What shall we build, together?

My Dear Community,

There are few greater fans of the Yellow Springs Community Foundation than me, and it has been my privilege to lead this organization for the past four years. Although I have lived in Yellow Springs for nearly 40 years, in the last four years you have taught me so much more about our community, its people and organizations; the deep caring we have for each other and what we can accomplish when we work together. For this I am enormously grateful, and I will take these experiences with me when I step down as president in March.

In many ways, 2017 is a new start for the Foundation. It is a new start because we recently hired our first Executive Director, Jeannamarie Cox. She is doing a marvelous job of carrying out our new strategic plan that you helped shape so the foundation may better serve our community. In this, we are developing new ways of supporting your philanthropic giving and grant making, enhancing our business processes to better support the outstanding work of our local non-profits and stepping up to convene the community.

Recent events in the village remind us that we still have significant work to do to ensure that our community continues to be all we need it to be. When students in our village feel unwelcome walking downtown because of their race, and are called subhuman and porch monkeys in our schools, it is clear we have more work to do. When a student essay appeared recently in the *YS News* describing the incident in school, there was not a single letter to the editor about it, no public outcry or community meeting. I admit, I was saddened by the silence.

We must not shy away from this work; not shy away from the difficult conversations about issues in our community. In the past, we have found such conversations both nurture and strengthen our community when we actively engage in them.

Our organization's founders guide us that the purpose of the Foundation is to "assist, encourage, and promote the well-being of humankind, and primarily the citizens of the Village of Yellow Springs and Miami Township," even when doing so may challenge our ideals and our comfort. The Community Foundation, through your support, has the financial resources and the duty to assist and encourage individuals and organizations in our village to be active citizens and to address issues like this, and others, in ways that make us all feel more whole and part of the community.

We get to decide every day what kind of community we want to live in and how we want to participate; we have many amazing organizations in this village to help us build it, and that is a beautiful thing. So, let's activate to build the kind of community we want to live in. The job of the Yellow Springs Community Foundation is to help us achieve it. What shall we build together?

The Annual Report introduces new members; this year, I am one. I sat down with Dorothy O. Scott, my mother, to ask her about why she introduced me to the Foundation.

ES: Did you realize I'm the first second-generation trustee in the Foundation's history?

DOS: I loved it when you came back to the Village and knowing you are as devoted to this community as I am, I was anxious to get you involved.

ES: My devotion comes from Dad and you. My brothers and I have

talked a lot over the years about how we had to share you with the Village growing up. Was it a conscious decision to show us what community involvement looked like?

DOS: No. We didn't do it to educate you in public service. It was organic. We cared about the community and we're people persons. I was raised in a household like that, too.

ES: As a kid, I had no idea how your community service was influencing me until I moved back here. It's become clear that I need to be of service in some way. It sounds like that was

your experience.

DOS: It was always because I was interested in or feeling committed to doing something if I could. Why the Community Foundation is particularly

appealing to me is that it is, indeed, the microcosm of the Village. It's available to any 501(c)(3) and we have very broad guidelines for grant making. There's a famous quote from Hardy Trolander from the Foundation's earliest days, "support something that's off the wall."

ES: At this point, do you see the Foundation having changed since your service?

DOS: If I had to choose one word, I'd say the Foundation has MATURED. We evolve because we're sensitive to how the community works, to trends in our larger society, and to our own sense of responsibility for how we can best serve this community.

ES: Agree, we are in the process of implementing our 2016 strategic plan which includes just those considerations; listening to what the community wants and needs and making whatever changes we must to meet them.

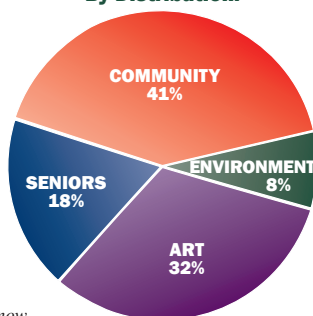

Ohayo-Ohio: A Japanese Symposium

It has long been recognized that one of the most impactful ways to work toward peace is for people to have personal opportunities to experience cultural awareness and to contextualize that experience. Former President Dwight Eisenhower



recognized this importance in a post-war establishment of the People to People program in 1956. The mission of People to People was “to enhance international understanding and friendship through educational, cultural, and humanitarian activities involving the exchanging of ideas and experiences directly among peoples of different countries and diverse cultures.” He noted, “If we are going to take advantage of the assumption that all people want peace, then the problem is for people to get together and to leap governments—if necessary to evade governments—to work out not one method but thousands of methods by which people can gradually learn a little bit more of each other.”



The Ohayo-Ohio symposium, 850 participants attending 30 separate events, provided a venue for this cultural awareness and contextualization toward international understanding and friendship through a cultural exchange of ideas and experiences. Several international villagers expressed gratitude that a symposium so focused on international culture could be offered in such a small village.

The Awesome Clay Dogs

The awesome “Clay Dogs” from Yellow Springs High School met at the John Bryan Community Pottery (JBCP) one day a week for eight weeks for a two-hour experience with clay, making such items as picture frames, clocks, magnets, decorative masks, bowls, and flower pots. One of the main goals of this project was



to help build a bridge between school, home, and community for these students. An Educational Endowment grant allowed for this exciting and rewarding partnering of the JBCP and the YS schools, specifically Jody Chick’s Intensive Needs class.

The students’ sessions were led by professional staff from the pottery and students were accompanied and/or assisted by Mrs. Chick, her two classroom aides, a JBCP board member who is a licensed Speech Pathologist, as well as other specialized staff from the school (physical therapist, speech therapist).

The course was designed utilizing Ohio Department of Education standards in the areas of visual arts, speaking and listening, and transitional goals for recreation leisure/self advocacy. A primary objective was to help with the transference of skills between school, home, and community by providing an accepting atmosphere with numerous opportunities for the students to practice and



strengthen their application of transitional life skills (thus future employability skills), including eye contact, meeting new people, recognizing and adjusting expected/unexpected behaviors, following directions, self esteem, patience, and handling frustration.

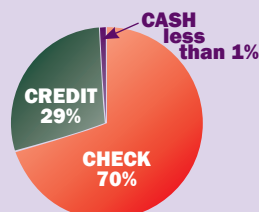

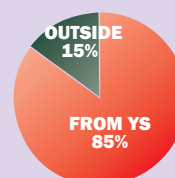

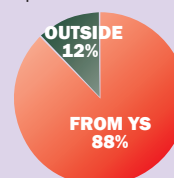

The purpose of the Miller Fellowship Program is to provide support for Antioch College students who engage in service for the benefit of the Yellow Springs community. The program was established in 2010 with a \$3 million bequest by the Nolan J. and Richard D. Miller Endowment Fund, which is

held as an endowment and administered by the YSCF. Nolan was associate editor of *The Antioch Review* and a beloved professor. His brother, Richard, was a highly regarded artist working in many different media.

The Yellow Springs Community Foundation awards grants directly to local nonprofits who then hire Antioch College students for meaningful work within their organizations.

To date, 23 local nonprofit organizations have applied and participated in the program, which offers a unique opportunity for students to secure a paid, one-year employment opportunity working for a nonprofit organization in Yellow Springs, Ohio. Students engage in the world of work receiving valuable projects and strong mentorship.
